Executive Summary:

This II Workshop on Reconceptualization of European Union Citizenship is intended to continue the analysis of the European citizenship under construction. Special attention will be pay to recent contributions of ECJ case-law that is -progressively-giving shape to the concept. While the idea of citizenship is always a concept that excludes human beings from a legal situation that others are going to enjoy, it is necessary to reach an inclusive model of European citizenship regarding third country nationals residents

and, indeed, to develop a status totally respectful with human rights (family and private life, superior interest of minors, humanitarian reasons, roots, etc.) The border between EU Law and the national law of the Member States needs to be revised in order to avoid loopholes that could risk the profile of the Rule of law.
